The winner will also co-host the Nunavut Day activities and perform other duties as president of NTI.

A panel of NTI judges will review your submission and select a winner. The name of the winner will be announced in May, 2013.

Submissions are due April 26, 2013.

If the winner already resides in Iqaluit, a cash prize of \$1,500 will be awarded.
